

Terms of Use

1. Introduction

These Terms of Use (“Terms”) govern the access to and use of the Hellenic Innovation & Infrastructure Fund (“HIIF” or “the Company”, “we”, “our”, “us”) website, platforms, and related services (collectively, the “Services”).

By accessing or using the Services, you (“User”, “you”) agree to be bound by these Terms. If you do not agree, please refrain from using the Services.

2. Purpose of the HIIF

The Hellenic Innovation & Infrastructure Fund (HIIF) is Greece’s new sovereign investment platform, under the Growthfund umbrella. HIIF is designed to mobilise private capital into strategic sectors that power Greece’s transformation - driving innovation, accelerating the green transition, and strengthening the country’s resilience.

With a seed capital of €300 million and ambitions to scale significantly, HIIF operates with commercial independence, rigorous governance, and global investment discipline. Its mission is to act as a catalyst for long-term growth, co-investing with leading partners and mobilising capital into high-impact areas such as digital infrastructure, renewable energy, the circular and blue economy, and advanced logistics.

Anchored in Greece’s national priorities and aligned with international best practices, HIIF provides institutional investors with a trusted and credible platform to pursue sustainable, high-growth opportunities while generating measurable socio-economic impact on the Greek economy. Through catalytic capital deployment, HIIF aims to unlock Greece’s next phase of development and position the country as a regional leader in innovation, energy, and connectivity.

HIIF was incorporated in July 2025 in compliance with Greek Law 5131/2024.

3. Eligibility and Access

- The Services are intended for professional and institutional users, including enterprises, investors, research bodies, and public authorities.
- Users must comply with all applicable laws and regulations in their jurisdiction when accessing the Services.
- Access to certain sections of the Services may require prior registration, approval, or submission of investment proposals.

4. No Investment Advice

- Users may download or print information solely for internal and non-commercial purposes, provided the source is acknowledged.

- Users may submit project proposals, investment requests, or partnership inquiries via the designated submission channels.
- By submitting materials, you grant the HIIF a non-exclusive, royalty-free license to review, assess, and store the submission for evaluation purposes.
- Confidentiality of submissions will be respected in accordance with HIIF's policies and applicable law.

7. Data Protection and Privacy

- Personal and organizational data collected through the Services will be processed in accordance with our Privacy Policy.
- Users are responsible for ensuring that any data provided is accurate, up to date, and does not infringe third-party rights.

8. Compliance and Prohibited Uses

Users agree not to:

- Use the Services for unlawful, fraudulent, or harmful purposes.
- Submit misleading, false, or incomplete information.
- Infringe on intellectual property rights of the HIIF or third parties.
- Interfere with the operation or security of the Services.
